### VALIDATION OF ENTRIES FOR INTERNATIONAL COMPETITION

#### On Line Entries and Paper Forms

- If an athlete submits an On LINE entry directly themselves, they do not need to complete a paper form. **ENTRIES CLOSES 12<sup>TH</sup> FEBRUARY**
- If an athlete wants to submit a paper form, they must complete the Paper Entry forms and send it with cheque to Judy Cooper who will then do that entry ON LINE.
- However each athlete **must complete** the **following athlete information form** and **pay** the AMA administration fee of **\$25-00**. This fee covers some of the cost of incidentals such as bank charges, postage and phone calls relating to entry verification as well as a contribution towards the Team Managers costs. Note that credit card payment is not available as AMA has no credit card facility. Home contact details are necessary for team management in case of an emergency.
- Entrants must be financial members of a State/Territory Masters athletic club. AMA will verify this information for validation.

**AUSTRALIAN UNIFORMS:** It should be noted that when competing in an international event it is **compulsory** for competitors to wear the uniform of their country and that for Australian competitors, only the current or immediate previous design will be recognized as the required uniform. Compression garments can be worn **under** your Australian uniform.

**RELAY TEAMS:** To assist selection, please indicate your interest in competing in the relay teams on the attached form. The relay is 4 X 200m. Age groups will depend on the available athletes. Teams are not selected until the entrants meet in Finland.

**TEAM MANAGERS:** AMA have selected Janet Naylor & Stuart Paterson as the team managers.

### REMINDER: WMA ANTI-DOPING REQUIREMENTS

Athletes are reminded that WMA strictly observes the IAAF Anti-Doping Rules. This means that a medical certificate explaining the use by an athlete of a prohibited substance, even for sound medical reasons, will not avail in the event of an athlete testing positive to a prohibited substance. The only exception is if the athlete is in possession of a Therapeutic Use Certificate ("TUE") issued to him/her either by the WMA Medical Officer or the assigned body provided for in IAAF Rule 34(5). It should be noted that in 2009 WMA adopted its own standard for the consideration and granting of TUEs and the Rules are listed on the WMA website. WMA athletes require TUEs for the use of beta-2 agonists as prescribed on the Prohibited List.

For athletes wishing to apply for a TUE, enquiries and written applications are to be submitted to the WMA Oceania regional Medical Officer
